The ball is rolling and we are getting things in order for the 2018 winter basketball league. We are shooting for Monday nights again, with January 8th as the tip-off for the first games. Also, depending on how many teams we have interested, we are looking at a 7 to 8 week season.

We suggest that you go ahead and begin recruiting players to form your teams as soon as possible to ensure that you have the personnel you need. The Code of Conduct, along with waivers, will need to be signed by each player on your team. **We will not have a formal meeting like we have in the past. All forms can be downloaded from our website (www.petalcbc.org) or hard copies can be picked up at the church office between the hours of 8:30 and 4:00, Mondays.-Thursdays/8:30 and 12:00 on Fridays. All forms need to be turned in to the church office by Thursday, December 14th to ensure that your team will be on the schedule!**

We are all approaching a busy time of year, and it's easy to forget about the upcoming deadlines. **We do want to secure who is playing, receive registration fees, and waiver documents in a timely manner. Please follow the instructions below if your church does intend on participating:**

1. Pick up liability waivers and code of conduct forms at the church office or download them from our website (www.petalcbc.org)
2. **GO OVER THE CODE OF CONDUCT FORMS WITH YOUR TEAM**
3. Fill out waivers and code of conduct forms and turn them in along with a **\$250 registration fee** per team to Calvary Baptist Church office by Thursday, December 14th (this fee covers use of facilities, cost of refs).
4. Expect a call from a Calvary Baptist Church representative to confirm that all needed forms/ fees have been received and to discuss game times/schedules.
